RESOLUTION NO. 2016 - 08**

**REPELAING RESOLUTION 2015-03  
ADOPTING A TITLE VI OF THE CIVIL RIGHTS ACT OF 1964  
POLICY REGARDING PROGRAMS OR ACTIVITIES RECEIVING FEDERAL  
FINANCIAL ASSISTANCE**

WHEREAS, the federal government enacted the Title VI of the Civil Rights Act of 1964, as amended, and other laws, regulations and executive orders to prevent discrimination on the grounds of race, color, religion, sex, disability, national origin, ancestry or status as a veteran (collectively or individually, “legally protected categories” or a “legally protected category”) and to ensure that individuals are not excluded from participation in, denied the benefits of, or otherwise subjected to discrimination under any program or activity receiving federal financial assistance on the basis of a legally protected category; and

WHEREAS, the Town of Bargersville (“Town”) desires to assure that no person shall on the grounds of a legally protected category be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity for which the Town receives federal financial assistance; and

WHEREAS, the Town will make every reasonable effort to ensure nondiscrimination with respect to legally protected categories in all of its programs and activities, regardless of funding source; and

WHEREAS, the Town will include non-discrimination language requiring compliance with Title VI in all written agreements and bid notices; and

WHEREAS, the Title VI Administrator shall be responsible for monitoring and initiating Title VI compliance in the areas of contracting and any program or activity for which the Town receives federal financial assistance; and

WHEREAS, the Bargersville Town Council (“Council”) shall establish a Title VI complaint procedure in accordance with federal law; and

WHEREAS, the Town’s Title VI policy and complaint procedure shall be publicly disseminated through the Town’s website and/or other appropriate avenues;

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF BARGERSVILLE, INDIANA:

Section 1. The Town Council of Bargersville adopts the following Title VI and non-discrimination policy: “It is the express policy of the Town of Bargersville that no person shall be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under, any program, services or activity receiving federal funds on the grounds of race, color, religion, sex, disability, national origin, ancestry or status as a veteran in accordance with federal law. It is also the policy of the Town of Bargersville to make every reasonable effort to ensure nondiscrimination with respect to race, color, religion, sex, disability, national origin,

ancestry or status as a veteran for all Town programs, services and activities regardless of its funding source.”

Section 2. The above policy shall be disseminated on the Town’s webpage and/or other appropriate avenues.

Section 3. Non-discrimination language in compliance with federal law and consistent with the Town’s Title VI and non-discrimination policy articulated in Section 1 shall be included in all written contracts and bid notices.

Section 4. The Council hereby appoints The Utilities Administrator as the Town's Title VI Administrator with respect to contracting and any program or activity for which the Town receives federal financial assistance


Section 6. The Council hereby appoints The Director of Development as the Town's ADA Administrator with respect to contracting and any program or activity for which the Town receives federal financial assistance


Section 7. The Council hereby adopts the Title VI complaint procedure attached hereto as Exhibit A and directs that it be posted on the Town's website and made available to the public through all other appropriate avenues.


Section 8. The Council directs the Title VI Administrator to prepare and present to the Council an annual Title VI and non-discrimination report to the Council no later than March 1 of each year.


